

## AMENDMENT TO THE AMENDED AND RESTATED BYLAWS OF MARINA BAY CLUB OF NAPLES CONDOMINIUM ASSOCIATION, INC.

The Amended and Restated Bylaws of Marina Bay Club of Naples Condominium Association, Inc. shall be amended as shown below:

Note: New language is underlined; language being deleted is shown in struck through type.

Section 4.1 of the Bylaws shall be amended to read as follows:

4.1 Number and Terms of Office. The number of Directors which shall constitute the whole Board of Directors shall be five (5). In order to provide for continuity of experience, all Directors shall be elected for two (2) three (3) year staggered terms with two (2) Directors being elected in even numbered years and three (3) Directors being elected in odd numbered years. A Director's term ends at the annual election at which his successor is to be duly elected. Directors shall be elected by the members as described in Section 4.3 below, or in the case of a vacancy between annual elections, as provided in Section 4.4 below.
